### **<Indonesia> Vans Inc Sues a Local Company**

Vans Inc., (a US company, plaintiff), files a lawsuit of cancellation of mark “Vans Off The Top” No. IDM000188574 (Class 25) and 15 other trademarks in the name of Kim Sung So (defendant) by Case No. 74/Merek/2012/PN.Niaga.JKT.PST at Commercial Court of Central Jakarta. Plaintiff states that trademarks owned by defendant has similarity in its essential part with well-known mark “Vans” No. IDM000229835 owned by plaintiff. Meanwhile, defendant states that defendant’s mark cannot be said as having similarity in its essential part with mark owned by plaintiff because both marks should be evaluated as a unity.

### **<Indonesia> “Kopi Kalosi” Will Obtain GI Certificate**

Head of Formality Examination of Mark Office, Saky Septiono, states that “Kopi Kalosi” (a kind of Arabica coffee from South Sulawesi) that was filed by Masyarakat Pelindung Kopi Enrekang (MPKE) will obtain certificate of Geographical Indication since it had passed the examination. In the market, this coffee is known as “Kopi Toraja”.

### **<Indonesia> Legal Standing of Plaintiff is Questioned**

Wen Ken Drug (defendant) refuse claim of Russel Vince (an English, plaintiff) because he has no legal standing in the cancellation lawsuit of trademark “Cap Kaki Tiga” owned by defendant. Defendant states that plaintiff is not the owner of trademark “Cap Kaki Tiga” so that he has no right to file the lawsuit. Previously, plaintiff ask judges of Commercial Court of Central Jakarta to cancel 49

trademarks “Cap Kaki Tiga” because they use symbol “Triskelion” that has been used in centuries by Isle of Men (a country colonized by United Kingdom).

### **<Indonesia> Gunze Limited Won Against Local Owner**

Commercial Court of Central Jakarta agrees to cancel trademark “The Gunze Sport” No. IDM000273135 (Class 25) in the name of Maryoto (defendant) because it has similarity in its essential part with well-known mark “Gunze” No. IDM000049044 (Class 23) owned by Gunze Limited (plaintiff). Previously, Gunze Limited asks judges of Commercial Court of Central Jakarta to cancel trademark “The Gunze Sport” No. IDM000273135 (Class 25) because it was filed with having bad faith and it has similarity in its essential part with their trademark “Gunze” No. IDM000049044 (Class 23).

### **<Indonesia> A Malaysian Company Asks Court to Cancel Trademark “Aladin”**

DKSH Malaysia Sdn.Bhd (plaintiff) asks judges of Commercial Court of Central Jakarta to cancel trademark “Aladin & logo” No. IDM000035246 (goods: matches) in the name of Muktar because it was filed with having bad faith and it has similarity in its essential part with their trademark “Alladdin & Device” No. IDM000035246 (goods: matches). Plaintiff states that their trademark has been registered in many countries.

PT Kreasi Mas Indah (plaintiff), in the case No.

of Trademark Appeal Commission  
No.93/KBM/HKI/2012. Previously, Trademark Appeal  
Commission decided to refuse application for registration

of trademark “Cruzz “ App. No. D002008007335 in the  
name of PT Kreasi Mas Indah because it has similarity in  
its essential part with a registered trademark “Crush” No.  
IDM000075853.
